BOARD MEMBER EXPECTATION STATEMENT

Not all of the following may apply to you, but we hope these points will provide examples of the skills and interests we are looking for in prospective board members:

Support ALL's mission, purposes, goals, policies, programs and services while knowing it's strengths and needs.

Actively participate in ALL fundraising events, special events, programs and activities.

Contribute ideas, strategies, activities to raise funds for ALL.

Attend activities and events sponsored by ALL.

Talk to people to promote ALL and actively solicit their membership in ALL.

Participate in all monthly open sessions of the board as well as possible additional board meetings.

Suggest agenda items for board and committee meetings to ensure that significant policy-related matters and public developments are addressed.

Agree that board members who make suggestions should be involved in implementing their suggestions.

Contribute your planning skills to the activities of ALL.

Help ALL focus and improve its operations, governance, policies and procedures.

Apply your specific skills to the long-range future planning of ALL.

Serve ALL as a whole rather than any special-interest group or constituency.

BOARD MEMBER EXPECTATION STATEMENT

Ask timely and substantive questions at board meetings consistent with personal conscience and convictions while supporting the majority decision on issues decided by the board.

Serve actively on committees and task forces.

Faithfully read and understand ALL's financial statements and otherwise help the board fulfill its fiduciary responsibility.

Suggest possible nominees to the board who you believe would make significant contributions to the work of the board and to the progress and success of ALL.

Exercise the highest fiduciary responsibility when in control of, transferring or handling ALL funds.

Agree to make an annual gift to ALL according to personal means, but no less than the minimum amount established by the board. This amount may change from year to year.

Personally raise funds for ALL using events or grants, or through your individual or institutional contacts.

Act in the most ethical manner. Avoid even the appearance of a conflict of interest that might embarrass the board or ALL and be willing to disclose any possible conflicts of interest in a timely manner. Never accept or offer favors or gifts from/to anyone who does business with ALL.
